**Notes:**

1. This form must be returned within 28 days of the adoption of the Code of Conduct or within 28 days of your election or appointment to office. You must register your Disclosable Pecuniary Interests in the Register maintained under Sections 30(3) and 235(2) of the Localism Act 2011 and provide written notification of details to the Council's Monitoring Officer.
2. You must within 28 days of becoming aware of any change to the interests specified above provide written notification to the Monitoring Officer of that change.

Please note some top tips for completing the forms:

- no blank boxes - if a box is not relevant, it needs to be "NIL" or "Non-applicable"
- in land - this includes the property that one lives in (whether rented, mortgaged, lease or licence, etc.) and I need to see the address (unless you live outside the parish boundary in which case it would be helpful to note this)
- in land - this includes any paddocks, other property and parcels of land and it must be identified on a plan or postcode
- employment - this must include any ad hoc work (handyman in village etc.) consultancy or whether a non-executive director, etc., and if retired but still does occasional work, it must be listed on the form.
