Welcome from Vice Chairman Cllr Paddy Donnellan, Cllr Foster is at an East Lindsey meeting and will join this meeting as soon as possible.

Public forum – Dog waste bin needs replacing outside Cooley's on Dogdyke Road. Two residents of Greenfield Road ask if Council could investigate the footpath that did run across the back of their houses and through to Pilgrim Square and Leagate Road. This footpath does not exist on any maps, this has been investigated but the Council requested the clerk get this confirmed.

Councillor Foster joined the meeting at 7.40pm

- 67.1 Chairman Cllr Foster thanked Cllr Donnellan for opening the meeting and apologised for his late arrival.
- 68.2 Apologies and reasons were heard from Cllr Moorhouse & Cllr Mason, Council **Resolved** to accept these. District Cllr Stan Avison sent apologies, County Cllr Tom Ashton aims to join us following a meeting at East Lindsey.
- 69.3 No declarations of interest at this point.
- Notes previously circulated from the meeting held 27th September, Cllr Johnson proposed, seconded Cllr Sharples that these be signed as a true and correct record, RESOLVED by vote, signed and dated by Chairman.
- 71.5 No Police report Cllr Mair asked if questions could be asked regarding increased street crime locally. Clerk will put the question to the beat team.
- 72.6 District Councillor Martin Foster, has been working with East Lindsey on the car park charges this was requested at the Annual Parish meeting in April, proposal is being put forward to council for a double visit per day plus a matched fee across the district for single car parks. This should hopefully be resolved very soon.
- 73.7 Gibbett Nook Cllr Mair raised the safety issues and requested that this be reviewed now that the new services are all in place, a series of accidents have occurred at this junction, Clerk to contact head of highways Richards Wills and the County Councillor Tom Ashton to look into this for Council. Cllr Marlene Wilson brought a copy of proposals made at the time of application to Highways for an in and out system, this was replied to by Richard Wills stating that this was a good idea but there was no money available to pay for it.
- 74.8 Burial Board meeting office 17th Oct Cllr Donnellan reported, contract discussed this being re assessed actual figures to be agreed at November meeting. Close monitoring for the first year, Clerks to check infantry list and report back to Council, all equipment to be kept initially to be sure of future. Burial board members to carry out checks on all headstones, photograph damage as seen prior to the new contractor start date. Proposal to give executive powers to Chairman and Vice Chairman to get additional work carried out on trees that have been identified. Seconded RESOLVED
- 75.9 Reports Service in the Field (Sibsey Lancaster) Chairman Fred Hunt has retired, Paddy Donnellan has taken on this role- date changed from 2019 onwards Last Sunday in September and hopefully this will help with possibly getting a flypast. LALC AGM, Cllr Mair attended membership will be increased £17.83 per year additional for Coningsby £650.03 in total, a presentation from West Lindsey planning officer, revealed that the problems being experienced here with East Lindsey are the same across the County.

- 76.10 **Remembrance 2018** Council made the decision to keep the running order of the day as traditional, this has unfortunately been overruled by the Church and the Padre's this year the muster point is each villages War Memorial with a member of the Church at each one with a service in the St Michael's Church at 11.45 The service at the Cemetery remains unchanged and will be at 2pm.
