Coningsby Town Council Meeting 27th September 2018

7.30pm Coningsby Community Hall

In attendance – Chairman Cllr Martin Foster, Cllr Paddy Donnellan, Cllr D Johnson, Cllr G Olive, Cllr C Mair, Cllr M Walker, Cllr R Sharples, Cllr K Moorhouse.

7 Members of public in attendance – Ben Rossi RAF communities' officer reported the new Station commander will be here mid-October; we already have a new OC base Dionne Warner. The RAF would be willing to offer letters of support or time to any funding bids.

Hoplands Rd development, road surface is becoming dangerous due to the heavy usage, this will need to be monitored as the developers will generally only re-surface on completion of build. Council was informed that some works had started on phase 4 –this will be investigated.

Dog bins and general waste bins are full – Clerk has been in contact with East Lindsey who explained that our local street cleaner is on annual leave. Cover has been allocated.

- 56.4 Notes previously circulated from the meeting held 26th July, ClIr Mason proposed, seconded ClIr Walker that these be signed as a true and correct record, RESOLVED by vote, signed and dated by Chairman.
- 57.5 Police report –PCSO Iliyana Edwards reported 6 anti social behaviour, 3 malicious communications,12 traffic collisions, damage only.Parking on double yellow lines around the village has been reported to parking enforcement LCC.
- 58.6 Cllr Foster in his role as East Lindsey District Councillor reported that 12 charging points have been funded by a company for EL one is to be placed in Coningsby car park. Cllr Foster has a small amount of his Cllr fund left if there any groups looking for funds please put them in touch with him. Cllr Johnson asked for an update regarding the car parking question 2 tickets per day and a possible reduction for persons on proof of working the village. Cllr Foster will follow this up with the leader of EL –clerk to write a letter from Council.
- 59.7 Outside groups Clir Mair gave a brief report on the youth club at Baptist Church every Friday 7.30pm. Clir Walker& Clerk reported on the networking day having attended today ,very well attended with interesting speakers, emphasis was again placed on the need for Councillors to attend training events throughout the year. Clir Donnellan reported on the site meeting with officers from EL Planning dept & LCC highways, all in all a very frustrating meeting with less than positive outcomes, EL refused to comment on anything other than the application in front of them, the number of dwellings on a single outlet has already been reached without an further development, this was pointed out by County Clir Tom Ashton, the officers had not realised this and said it would be investigated, (no changes or recommendations to the application have been made following this meeting) Planners and Highways said the requests need to come from the other for changes in road structure.

Section 106 money has been requested and agreed for NHS also a request has been received for local schools. Cllr Foster explained that the whole of East Lindsey has very similar problems; Cllr Stan Avison is working with the Environment agency trying to remove the flood risk from the Tattershall area due to the lack of evidence. Council requested that the clerk investigates who or where to go with the problem in government, also keeping local MP Victoria Atkins informed.

Council requested a strongly worded document be sent to the MP, leader of EL district Council, the Chief Executive EL also ask the question of other councils suffering the same issues. PROPOSAL to arrange to meet with others to discuss the way forward, Cllr Olive, seconded Cllr Mair, all voted in favour. Clerk to report back on investigations.

60.8 Modification of Footpath no.1124 – School Lane /Providence Place/Dogdyke Rd, the outcome states that the section of path from Orchard Way to Dogdyke Rd remains closed the section from Orchard way across Providence place remains open. Cllr Moorhouse – Council need to take this as a warning and take stronger action in any future disputes otherwise Coningsby will end up with no rights of way.

61.9 **Pavilion /Football Club** – two meetings have been held, the FC agreed to clear some of the old unused goods from the garage, at the second meeting it was established that there is some equipment that belongs to the Council that could also be moved, some needs scrapping and others equipment which may be useful in the future will be moved to the Cemetery Chapel for storage. The area is thought to be big enough for both the Council storage and the Football Club use with a bit of rearrangement, Proposal to purchase a lockable cabinet for the Caretakers chemicals and paper goods; seconded all in favour. Prices are being sought for drainage outside the front of the building. Signage to be installed in all rooms stating "No goods to be left in these premises" "Any goods left will be removed and placed in the garage for one month" All agreed.

Kitchen has been ordered from Wickes, James Bowen is fitting at earliest opportunity. Insurance company have paid in full for all works.

Mr Bill Stennett has retired from the job as relief clock winder, Council have appointed Mr John Pinion who has undergone training with Mr Peter Bass, John Pinion has done a week's winding and is happy to continue. Council Confirmed Mr Pinions appointment, he will also be carrying other works if required. Paddy Donnellan has also volunteered as a relief for emergency purposes.

The Cemetery CT has accepted the terms offered for change of contract, he will be working on a zero hours contract from December onwards.

A meeting of the burial board is to be held on 17th October 6pm prior to contacting the chosen contractors Glendale (as agreed previously) to iron out any issues moving forward.
