LINCOLNSHIRE PERMIT SCHEME FOR ROAD WORKS AND STREET WORKS (VARIATION) ORDER 2025

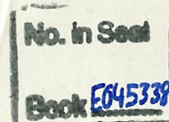
The Lincolnshire County Council in exercise of its powers under sections 33 & 33A of Part 3 of the Traffic Management Act 2004 and the Traffic Management Permit Scheme (England) Regulations 2007 ("the 2007 Regulations") as amended by the Traffic Management Permit Scheme (England)(Amendment) Regulations 2015 and having had regard to applicable Guidance in relation to Traffic Management Permit Schemes makes the following Order:-

1. The Lincolnshire Permit Scheme for Road Works and Street Works Order 2016 (the "2016 Order") is varied as specified in the Schedule below.
2. The Order shall come into operation on the 5th day of January 2026 and may be cited as the Lincolnshire Permit Scheme for Road Works and Street Works (Variation) Order 2025.
3. The Table of Fees in Appendix D of the 2016 Order is replaced with the revised permit fee schedule set out the Schedule below.
4. A notice of this Variation Order shall be published in accordance with regulation 3 of the 2007 Regulations and shall be made available at the principal offices of Lincolnshire County Council and on the official website of Lincolnshire County Council at www.lincolnshire.gov.uk
5. The new fees shall apply to all permit applications submitted on or after 5th January 2026.

Schedule 1: Revised Permit Fee Structure

Provisional Advance Authorisation	£105	£75
Major Activity greater than 10 days duration or requiring a TTRO	£240	£150

Major Activity up to 3 day duration	£65	£45
Standard activity	£130	£75
Minor Activity	£65	£45
Immediate activity	£60	£40
Permit Variation	£45	£35

Explanatory Note

(this Note does not form part of the Order)

This Variation Order amends the **Lincolnshire Permit Scheme for Road Works and Street Works 2016** which established the Lincolnshire Permit Scheme under Section 33/33A and Part 3 of the Traffic Management Act 2004.

The purpose of this Variation Order is to revise the permit fee structure under the scheme to ensure compliance with Regulation 16A of the 2007 Regulations which requires that permit fees reflect the reasonable costs of operating the permit scheme without exceeding those costs.

The revised fees will take effect from **5th January 2026** and will apply to all permit applications submitted on or after this date. Transitional provisions have been included to ensure that applications made prior to this date will remain subject to the fee provisions of the 2016 Order.
